Limited offerings prevailed on light to fair trade inquiry. Food service and retail demand improved over the holiday weekend; moderate to good with only light to fair demand noted today. Floor stocks generally in balance. Weights were in a desirable range. Supplies of whole and boneless/skinless breasts adequate, leg quarters and wings available, and thighs, thigh meat and leg meat were plentiful. Trade sentiment was mostly steady with undertone weak on thighs, thigh meat and leg meat.
