MIDWEST BROILER/FRYER - Final majority prices were unchanged in Chicago and Detroit; slightly higher in St. Louis from Monday's final; Ohio cities TFEWR. Whole fryer trade sentiment was about steady. Offerings of whole fryers adequate. Retail and food service demand was light to moderate, instances good into fast food. Floor stocks adequate to ample with some reductions of regular commitments noted. Weights desirable. Supplies of breast cuts fully adequate to ample, wings tight, and leg quarters adequate to close. The market tone was fully steady on wings, steady on dark meat items, and barely steady to weak on breast cuts.
