MIDWEST Preliminary delivered majority prices into the Chicago area for next week were unchanged. Whole broiler/fryer market tone was mostly steady. Fill-in trade reported into the Ohio area on 3 pound wogs at 60 cents. Offers were in close balance on mid-weight birds and fully sufficient on other sizes. Movement into all channels was mixed, light to fairly good; best for aggressive retail features and food service convenience items. Floor stocks were adequate to long; weights mixed. Parts trade was limited to as need basis with offering fully sufficient for current draw. The market tone on all parts was mostly steady, instances weak on dark meat cuts.
