NATIONAL EGG MARKET AT-A-GLANCE

Regional prices were sharply higher on larger sizes and Mediums. New York prices were unchanged. Trade sentiment was steady to fully steady. Demand into all channels was light to fairly good. Supplies were barely sufficient to sufficient for immediate trade needs. Breaking stock offerings were barely adequate to tight; processing schedules were normal to less than normal. Light type hen offerings were sufficient to readily available for the moderate to good demand.

MIDWEST Prices were sharply higher for warehouse and store door delivery and unchanged for producer. The trade sentiment was steady to fully steady. Cartoned shell egg demand was light to moderate. Loose shell egg demand was light to moderate at best. Supplies were adequate to closely balanced. Central states breaking stock prices were unchanged. Demand was moderate to fairly good for the tight offerings. Floor stocks tight to barely adequate. Processing schedules full-time to reduced. Trade sentiment was steady.

Eastern region breaking stock offerings were barely adequate to tight for the moderate to fairly good demand. Light hen offerings were at best sufficient; processing schedules were normal.

The Pacific inventory increased 2% from last Monday, with California up 4% and OR-WA-UT down 1%. Demand was moderate to good with offerings balanced to adequate on the larger sizes and adequate to instances short for mediums. Floor stocks adequate to very closely balanced.

<u>CALIFORNIA</u> Prices were 13 cents higher for jumbo, up 11 cents for extra large, increased 13 cents for large, and 19 cents higher for medium and small. Trade sentiment was steady. The Pacific inventory increased 2% from last Monday, with California up 4% and OR-WA-UT down 1%. Demand was moderate to good with offerings balanced to adequate on the larger sizes and adequate to instances short on mediums. Floor stocks adequate to very closely balanced.
