NATIONAL BROILER MARKET AT-A-GLANCE



Whole broiler/fryer prices are steady overall. Final majority prices are unchanged in all areas when compared to last week prices. Offerings cover the full range, mostly moderate. Retail and food service demand is light to moderate following the weekend. Floor stocks are balanced to instance long. Market activity is slow to moderate. In the parts structure, movement is light to moderate as dealers assess market conditions entering the week. Prices for wings continue to trend firm to higher and steady to at least steady for the balance of items. Offerings are light for wings and commanding premiums. Breast items and most dark meat items are moderate. Market activity is seasonally slow to moderate. In production areas, live supplies are moderate at mixed, but mostly desirable weights.

NORTHEAST REGION BROILER/FRYERS Prices are trending steady for most sizes. Trucklot buying activity on ready-to-cook whole broiler/fryers is light to moderate as dealers assess market conditions entering the week. Offerings of all sizes are moderate for current needs. Trade activity is seasonally slow to moderate. In the parts complex, supplies of wings are light with good movement; breast items and dark meat cuts are sufficient for current needs with tenderloins noted in the better balance.

<u>SOUTHERN REGION BROILER/FRYER</u> Whole broiler/fryer prices are steady. Offerings of all sizes are moderate to satisfy trade needs. Demand following the weekend is seasonally light to moderate with trading usually limited to regular commitments. Market activity is slow to moderate. In the parts structure, movement is light to moderate for early week trading. Prices for wings are firm to higher and moving well. Breast items and dark meat cuts are moderate. Supplies of wings are light and moving well. All other parts are mostly moderate. Market activity is slow to moderate. In production areas, live supplies are moderate. Weights are mixed, but mostly desirable.

WESTERN REGION BROILER/FRYERS Final majorities were unchnaged from last Monday. Offerings light. Retail and food service demand light to moderate. Floor stocks light to moderate. Sizes adequate. Parts supplies light to moderate. The Los Angeles negotiated WOG weighted average is 79.48 cents, down 1.93 cents on 33 loads. Trading: boneless skinless breasts 120-133, tenders 137-152, bone-in breasts 83-108, legs 69-82, leg meat 110-117, leg quarters bulk 52-61, 4-10 leg quarters 54-65, drums 58-70, thighs 63-85, thigh meat 110-129, wings 137-151 cents delivered.

MIDWEST REGION BROILER/FRYERS - Final majority prices were unchanged into the Chicago market; Ohio cities, Detroit and St. Louis were TFEWR. Whole broiler fryer prices trended steady with offerings light to moderate. Retail and food service demand was light to moderate with fast food normal to good. Floor stocks were balanced to instances long. Sizes were in a full range. Whole bird market activity was light. Supplies of wings were tight with breast cuts and dark meat items light to moderate. Prices were firm on wings and steady on the balance of parts. Market activity for parts was light to moderate with most interest on wings.

<u>DELMARVA BROILER/FRYERS</u> Less-than-trucklot asking prices are unchanged at 78 to 84 cents with a steady trending undertone. Movement of ready-to-cook whole birds is light to moderate as dealers assess current market conditions entering the week. Offerings ranged moderate to at times heavy. Live supplies are moderate; weights are mixed, but reported as mostly desirable. Processing schedules are moderate. Market activity is seasonally slow to moderate. In the parts complex, supplies of wings are light and noted in the best position. The balance of items are moderate.

Northeast Broiler/Fryer Parts Prices are trending firm to higher for wings and steady to at least steady for the balance of items. Trucklot buying activity was noted as light to moderate as dealers assess market conditions entering the week. Offerings of wings are light and commanding premiums; breast items and most dark meat cuts are moderate for the light and unaggressive buyer interest. Movement is seasonally slow to moderate.

National Mechanically Separated Chicken

(FOB Shipper Dock or equiv., negotiated prices in trucklot and less-than-trucklot volumes reported in thousand lb. quantities, cents/lb.; delivery within 2 weeks.)

Prices of MSC trended steady to fully steady on all fat contents. MSC supplies were light to moderate. Schedules were normal. Domestic demand was light to instances good. Export demand was moderate to good with frozen 15-20% receiving best call. The spot marketplace was a bit stronger this week as buyers work to build inventories for the upcoming holidays and take advantage of cheaper contract pricing before the start of 2012. A few contract negotiations continue to wrap up, but most pricing for 2012 has been finalized on either a formula basis or at higher levels than those seen in 2011 and most preceding years. Market activity was light to active. Supplies of raw materials were light. Frames traded between 14-19 cents FOB.




