Regional prices are 19 cents higher on Jumbos, 21 to 25.5 cents higher on Extra Large, up 21 to 25.50 cents on Large, 9 to 23 cents higher on smaller sizes. New York prices are unchanged. The undertone is steady. Offerings are light to moderate with heavier weight eggs in the lighter position. Demand into retail and food service channels is mixed, mostly moderate to fairly good. Market activity is moderate to instances active. Breaking stock offerings are light to moderate; demand is moderate to good. Light type hen offerings are sufficient to fully sufficient for normal processing schedules.
