This period, New York prices are higher for extra-large and large but lower for medium. Early in the week, regional prices increased for the larger sizes and decreased for mediums. Next week's regional asking prices are trending higher for the heavier weight eggs and lower for the lighter weights. The undertone is steady. Retail demand is mostly moderate to fairly good. Food service demand is light to moderate. Offerings are light to moderate, instances heavy. Market activity is mostly moderate. Breaking stock prices are steady. The undertone is steady. Demand is light to moderate with offerings light to mostly moderate. Supplies are moderate. Market activity is slow. North Central regional light type hen removal costs continue steady. Offerings are light for the moderate to good demand. Schedules are full-time. Market activity is moderate.

WEEKLY FRYERS AVAILABLE FOR MARKETING

Based on the preliminary chick placements, the number of fryers available for marketing during the week ending 16-Jul-11 is estimated at 158.8 million head. This compares to 159.7 million head the previous week and to 161.5 million head the same week a year ago, when the slaughter was 146.8 million head and the composite weighted average price was 88.47 cents per pound.
