DOMESTIC MARKET HIGHLIGHTS

The market on fresh and frozen hens and 16-24 lb. toms is steady to firm. Fresh demand fair to instances good for deferred shipments. Frozen demand fair. Frozen hen offerings very light to light with 8-12 lb. sizes least available. Frozen 16-24 lb. tom offerings very light to light. Frozen Grade A basted equivalent processor offering prices on a national basis for hens 108.00-114.50 cents fob and 16-24 lb. toms 108.00-114.50 cents fob for current deliveries. Trading very light on frozen basted equivalent hens at 110.50 cents fob for current shipments.

The market on white meat and white trims is generally steady. Demand light to good, mostly fair. Offerings very light to moderate. The market on institutional sized breasts is steady with a steady to firm undertone. Demand fair to good. Offerings very light to light. The market on tom bulk parts is steady with a steady to sometimes firm undertone. Demand light to mostly fair. Offerings light to moderate. The market on thigh meat is steady at best. Demand light to fair. Offerings moderate. The mechanically separated turkey market is steady to weak. Demand light. Offerings moderate to heavy. Trading slow.

Market activity for parts is slow. For domestic: fresh full cut wings 73 cents, fresh tom necks 65 cents, frozen tails 58 cents, grade A breast non basted 14-16 lbs. 210 cents and 18-20 lbs. 215 cents delivered. For export: fresh tom drums 90 cents delivered to Border.
